Procurement Process & Timeline

- July 6, 2015 – Request for Proposals Issued
- July 24, 2015 – Q&A Process Completed
- August 3, 2015 – Submittals Received (2)
- August 10, 2015 – Evaluation Committee Meeting
- August 12, 2015 – CRRMA Board Selects Operator (proposed)
- August 18, 2015 – Operations Agreement executed (est.)
