

# **CAMINO REAL REGIONAL MOBILITY AUTHORITY BOARD RESOLUTION**

**WHEREAS**, the Camino Real Regional Mobility Authority (the CRRMA) issued a Request for Proposals to provide Underwriting Services (the RFP) on January 30, 2014 in order to update its pool of potential underwriters;

**WHEREAS**, the CRRMA Board of Directors selected its updated Underwriting Pool pursuant to and in accordance with the RFP via Board Resolution of April 9, 2014, thereby identifying various underwriters from which the CRRMA may select individual underwriters or a pool of such underwriters, as necessary, from time to time;

**WHEREAS**, the CRRMA Board desires to issue certain bonds associated with the County of El Paso's Vehicle Registration Fees, per the 2013 El Paso County Comprehensive Mobility Plan and therefore desires to establish an Underwriting Syndicate for such proposed bond issuance; and

**WHEREAS**, the CRRMA now desires to select the referenced Underwriter Syndicate for the proposed Vehicle Registration Fee bond issuance;

**NOW, THEREFORE, BE IT RESOLVED BY THE CAMINO REAL REGIONAL MOBILITY AUTHORITY:**

**THAT** the CRRMA hereby selects the Underwriting Syndicate for the proposed Vehicle Registration Fee bond issuance proposed as part of the 2013 El Paso County Comprehensive Mobility Plan as more fully identified within **ATTACHMENT "A"** to this Board Resolution; and **THAT** the Executive Director is authorized to take such steps as may be necessary to effectuate the intent of this Board Resolution.
