Section A. – Scope of Services

The GEC shall provide various general engineering support and related services to the Authority as more fully enumerated within **EXHIBIT** "A", which is attached hereto and incorporated herein for all purposes.

Section B. - Schedule

The GEC shall provide such engineering and related services to the Authority as requested from time to time by the Executive Director of the Authority. The period of performance shall commence upon the request of the Executive Director of any particular task and shall continue for a period to be agreed upon by the Executive Director and the GEC, dependent upon the nature of the services requested.

Section C. – Compensation

The total cumulative compensation for services requested by the Authority pursuant to this **Supplemental Work Authorization No. 9B** shall not exceed TEN THOUSAND AND 00/100 DOLLARS (\$10,000.00), subject to and in accordance with the Fee Summary dated May 24, 2013, which is attached to and incorporated herein as **EXHIBIT "B"**. The fees included in **EXHIBIT "B"** are based on the hourly rates and other charges established within the Agreement. Compensation shall be made in accordance with the Agreement. Invoices shall be provided by the GEC in accordance with the requirements enumerated within WA#9.

Except to the extent expressly modified herein, all terms and conditions of the Agreement and WA#9 shall continue in full force and effect.
