

**CAMINO REAL REGIONAL MOBILITY AUTHORITY  
BOARD RESOLUTION**

**WHEREAS**, the Camino Real Regional Mobility Authority (CRRMA) has entered into various agreements with El Paso County (County), which authorized the CRRMA to utilize the proceeds of an optional vehicle registration fee (VRF) imposed by the County to issue bonds for the development of various transportation projects in the County as part of the 2013 El Paso County Comprehensive Mobility Plan; and

**WHEREAS**, the County and CRRMA entered into additional agreements to allow for the CRRMA to fund the construction work necessary for the Vista del Sol Drive Project (the Project) from the referenced VRF bond proceeds; and

**WHEREAS**, the CRRMA had previously advertised a construction letting for the Project, has since opened bids and now desires to select the lowest responsible bidder to begin construction activities for the Project.

**NOW, THEREFORE, BE IT RESOLVED BY THE CAMINO REAL REGIONAL MOBILITY AUTHORITY:**

**THAT** the CRRMA hereby selects [REDACTED] as the lowest responsible bidder in response to the CRRMA's procurement for the Vista del Sol Drive Project; and **THAT** the CRRMA's Executive Director is authorized to execute a construction contract with [REDACTED] for construction of the Vista del Sol Project.

The Contractor agrees to commence work on a date to be specified in a written "Notice to Proceed" issued by the Owner. The Contract Time shall begin on the date to commence work specified in the "Notice to Proceed." Contractor shall Substantially Complete the Project within **THREE HUNDRED NINETY SIX (396) WORKING DAYS** after the date to commence work in the "Notice to Proceed." Contractor agrees to pay, as liquidated damages, the sum of **EIGHT HUNDRED DOLLARS AND ZERO CENTS (\$800.00)** for each working day after the expiration of the Contract Time for any remaining work, as provided in Item 8L of the Specifications. The unit price quantities of this contract are estimated.
