THAT the Executive Director is hereby authorized to execute Change Order No. 07 with Kapsch TrafficCom Transportation NA (formerly known as Telvent USA LLC) as it relates to the relocation of certain toll equipment currently located at the City of El Paso Zaragoza port of entry facilities, including any additional documents or materials as may be necessary.

CHANGE ORDER NO. 7

Chavez Tolling Equipment Move Located at Zaragoza Bridge Building

THIS CHANGE ORDER is made this, day of 2017, pursuant to the terms and conditions of the Agreement for Toll System Integration and Maintenance, dated December 12, 2012 (the Contract) entered into by and between the Camino Real Regional Mobility Authority ("CRRMA"), and TELVENT USA LLC ("Contractor"), now known as Kapsch.
PART I. The Contractor will remove and reinstall tolling equipment located at the Zaragoza Bridge building. Moving the tolling equipment will require building a new rack and correctly routing fiber. Tolling will cease for no longer than six hours and will be confirmed as operational before leaving the premises.
PART II . The maximum amount payable under this Change Order No. 7 is \$9,052.83. This amount is based upon the estimated fees set forth in the Cost Exhibit included in Attachment A .

PART III. Payment to the Contractor for the services established under this Change Order No. 7 shall be made in accordance with all applicable provisions of the Contract.

PART IV. This Change Order shall become effective on the date of final execution by the parties hereto and shall terminate after final acceptance, unless extended by a supplemental Change Order as provided in the Contract.

PART V. This Change Order No. 7 does not waive any of the parties' responsibilities and obligations provided under the Contract, and except as specifically modified by this Change Order, all such responsibilities and obligations remain in full force and effect.
