Paso Del Norte Trackworks (PDNT) is submitting pricing for alternative grout material to be installed over the UP bridge troughs on Kansas and Santa Fe.

Due to existing field conditions over the UP Bridges located on Kansas and Santa Fe, the rail profile at these locations had to be revised. With the revised rail profiles, the Contract specified Quikrete Fiber-Reinforced Deck Mix aggregate of 3/8" would be too large to provide support underneath the base of the rail. PDNT proposed an alternative product (Type 1 Elastomeric Grout) which was approved in RFI-00300 (attached). The cost of the alternative material is illustrated in the attached documents.
