WHEREAS, the County has identified additional project funding and now requests the CRRMA to provide additional coordination support, design and letting services for the fuel farm improvements planned for the El Paso County Fabens Airport.

NOW, THEREFORE, BE IT RESOLVED BY THE CAMINO REAL REGIONAL MOBILITY AUTHORITY:

THAT the CRRMA hereby authorizes its Chair to execute a third amendment to the Interlocal Agreement with El Paso County for the design of a fuel farm and automated weather observing system (AWOS) for the El Paso County Fabens Airport, for additional coordination support, design and letting services for the fuel farm improvements.

INTERLOCAL AGREEMENT PROJECT DEVELOPMENT AGREEMENT FOR THE FABENS AIRPORT FUEL FARM AND AWOS PROJECT

THIS THIRD AMENDMENT TO THE INTERLOCAL AGREEMENT	Γ (the
"Amendment") is made and entered into effective as of the day of	, 2024
by and between EL PASO COUNTY, TEXAS (the "County") and the CAMINO	REAL
REGIONAL MOBILITY AUTHORITY ("Authority"), (collectively, the "Parties"), f	or the
purposes described herein.	

WITNESSETH:

WHEREAS, the County and Authority entered into an Interlocal Agreement – Project Development Agreement for the Fabens Airport Fuel Farm and AWOS Project [2021-0058] dated February 22, 2021, as revised by Amendment No. 1 [2023-0554] dated August 7, 2023 and Amendment No. 2 [2023-0754] dated October 16, 2023 (collectively referred to as the "Interlocal Agreement") whereby the County was to provide funds to the Authority for the design and construction of certain improvements at the El Paso County Fabens Airport, including an automated weather observing system ("AWOS") and a fuel farm expansion (collectively referred to as the "Project"); and

WHEREAS, the Parties now desire to further amend the Interlocal Agreement to provide the additional funding necessary for additional coordination support, design and letting services for the fuel farm component of the Project, as requested by El Paso County.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the undersigned Parties agree as follows:

- 1. Replacement of EXHIBIT C-2. The Parties hereby agree to delete EXHIBIT C-2 from the Interlocal Agreement in its entirely and replace it with EXHIBIT C-3, which is attached hereto. Further, any references within the Interlocal Agreement to "EXHIBIT C" or "EXHIBIT C-1" or "EXHIBIT C-2" shall be replaced with "EXHIBIT C-3".
- 2. Payments from the County. The County shall transfer any Project funds added by **EXHIBIT C-3** of this Amendment to the Authority within ten (10) days of the date first noted above.
- **3. Ratification.** Except as expressly amended by this Amendment, the Interlocal Agreement and its exhibits shall remain in full force and effect.

4. Execution in Counterparts. This Amendment may be simultaneously executed in several counterparts, each of which shall be an original and all of which shall be considered fully executed as of the date first written above, when both Parties have executed an identical counterpart, notwithstanding that all signatures may not appear on the same counterpart.
