The CRRMA began the quarter with \$54.8 million and ended the period with \$70.4 million. The increase is primarily attributed to funds provided by El Paso County and EPWU for several projects including John Hayes, County Transit Facility, and Fabens Airport AWOS. During the quarter, the CRRMA earned \$818k.

<u>Outlook</u>: The Fed held rates steady (5.25% - 5.5%) at its March meeting while continuing to signal that it expects to cut rates three times during 2024 with the first potentially in June. The CRRMA will continue to use longer duration treasuries to provide increased yield when appropriate.

All investments in the portfolio are compliant with the CRRMA's Investment Policy and the relevant provisions of the Texas Public Funds Investment Act.
