THAT the Executive Director be authorized to execute **Amendment No. 1** to **Work Authorization No. 24.1** with AtkinsRéalis USA Inc. including any additional documents or materials as may be required, for the provision of certain additional right of way acquisition and associated support services required for the Darrington Roadway Improvement Project.

WORK AUTHORIZATION NO. 24.1

AMENDMENT NO. 1

This Amendment No. 1 to Work Authorization No. 24.1 is made as of the last date noted below (the "Amendment"), under the terms and conditions established in the AGREEMENT FOR GENERAL CONSULTING ENGINEERING SERVICES, dated as of August 22, 2022, (the "Agreement"), between the Camino Real Regional Mobility Authority ("Authority") and Atkins North America, Inc., now known as AtkinsRéalis USA Inc. ("GEC"). This Amendment is made for the purposes identified below, consistent with the services defined in the Agreement.

The Authority and the GEC previously executed **Work Authorization No. 24.1** for the GEC to provide certain right of way acquisition services necessary to support El Paso County in its planned reconstruction and widening of Darrington Road between Eastlake Boulevard and Pellicano Drive (Project). This **Amendment No. 1** is intended to supplement **Work Authorization No. 24.1** to allow the GEC to provide additional right of way acquisition services not originally contemplated within **Work Authorization No. 24.1**. The terms and additional compensation for this Amendment are more fully enumerated herein.

Therefore, and in consideration of the mutual covenants and agreement between the parties, the Authority and GEC hereby agree to the following.

Section A. – Scope of Services

The GEC shall provide additional general engineering support and related services to the Authority pursuant to and in accordance with **EXHIBIT A-3** to this Work Authorization, which is incorporated herein for all purposes. These additional services shall supplement those originally identified within **Work Authorization No. 58**, as amended.

Section B. – Schedule

The GEC shall commence the performance of the additional services contemplated herein, upon execution of this Amendment.

Section C. – Compensation

In return for the performance of the additional services requested herein, the Authority shall pay to the GEC an additional not to exceed amount of SIXTY-FIVE THOUSAND TWO HUNDRED TWENTY-THREE AND 76/100 DOLLARS (\$65,223.76), based on the Fee Estimate Summary, which is attached hereto for all purposes as **EXHIBIT B-1.** Accordingly, the total not to exceed amount from **Work Authorization No. 24.1**, including **Amendment No. 1**, shall be ONE HUNDRED SEVENTY-SEVEN THOUSAND NINE HUNDRED NINETY-TWO AND 18/100 DOLLARS (\$177,992.18). Compensation shall be made in accordance with the Agreement. Invoices shall continue to be provided by the GEC in accordance with **EXHIBIT C** of **Work Authorization No. 24.1**.

Except to the extent expressly modified herein, all terms and conditions of the Agreement shall continue in full force and effect.
