# ADVANCE FUNDING AGREEMENT For Metro Mobility On-System

#### AMENDMENT #2

**THIS AMENDMENT** is made by and between the State of Texas, acting through the **Texas Department of Transportation**, called the "State", and the **Camino Real Regional Mobility Authority**, acting by and through its duly authorized officials, called the "Local Government". The State and Local Government shall be collectively referred to as "the parties" hereinafter.

#### WITNESSETH

WHEREAS, the parties executed a contract on April 11, 2024, to effectuate their agreement to construct a two-lane westbound frontage road and ramp improvements from Executive Center Blvd. to Sunland Park Drive; and,

WHEREAS, the parties executed Amendment #1 to the contract on August 8, 20024, to increase the total estimated cost of the project by \$78,047.74 from \$32,958,084.72 to \$33,036,132.46; and,

WHEREAS, it has become necessary to amend that contract in order to increase the total estimated cost of the project by \$148,392.89 from \$33,036,132.46 to \$33,184,525.35:

**NOW THEREFORE**, in consideration of the premises and of the mutual covenants and agreements of the parties, the parties do agree as follows:

#### **AGREEMENT**

Attachment B, **Project Budget**, is deleted in its entirety and replaced with Attachment B-2, **Project Budget**, which is attached to and made a part of this Amendment. The total estimated cost of the Project <u>increased</u> by \$ \$148,392.89, from \$ 33,036,132.46 to \$ \$33,184,525.35, due to increase in estimate for **Preliminary Engineering caused by expenses related to necessary re-design of roadway and roadway elements.** 

All other provisions of the original contract are unchanged and remain in full force and effect.
