Purpose of the IDC Procurement

The intent of this IDC procurement is to develop a list of pre-approved professional engineering firms that will be available to the CRRMA to develop various projects, on an as-needed basis.

This procurement seeks various types of professional services, including examples like:

- Surveying;
- Right-of-way Mapping;
- Coordination with local, state, and federal agencies;
- Schematic Design;
