

CAMINO REAL REGIONAL MOBILITY AUTHORITY BOARD RESOLUTION

WHEREAS, El Paso County (County) and the Camino Real Regional Mobility Authority (CRRMA) executed an Interlocal Agreement – Project Development Agreement for the Alamo Alto Trail Project, Phase 2 (Tornillo) dated October 17, 2022 (Interlocal Agreement), which provided funds for the design of certain shared use path/trail improvements referred to locally as Phase 2 of the Alamo Alto section of the Paso del Norte Trail within Tornillo, Texas; and

WHEREAS, the parties executed subsequent amendments to the Interlocal Agreement to advance the design plans for the referenced improvements and the parties now desire to further amend the Interlocal Agreement to increase available project funding, in order to commence construction activities.

NOW, THEREFORE, BE IT RESOLVED BY THE CAMINO REAL REGIONAL MOBILITY AUTHORITY:

THAT the CRRMA hereby authorizes its Chair to execute a Fourth Amendment to the Interlocal Agreement – Project Development Agreement for the Alamo Alto Trail Project, Phase 2 (Tornillo) with El Paso County to increase available funding for the commencement of construction activities.

FOURTH AMENDMENT
INTERLOCAL AGREEMENT
PROJECT DEVELOPMENT AGREEMENT FOR THE
ALAMO ALTO TRAIL PROJECT, PHASE 2 (TORNILLO)

THIS FOURTH AMENDMENT TO THE INTERLOCAL AGREEMENT (the “Amendment”) is made and entered into effective as of the last day noted below, by and between EL PASO COUNTY, TEXAS (the “County”) and the CAMINO REAL REGIONAL MOBILITY AUTHORITY (“CRRMA”), (each a “Party” and collectively, the “Parties”), for the purposes described herein.

WITNESSETH:

WHEREAS, the County and CRRMA entered into an Interlocal Agreement – Project Development Agreement for the Alamo Alto Trail Project, Phase 2 (Tornillo) dated October 17, 2022 [2022-0231], as amended by the First Amendment dated July 24, 2023 [2023-0551], the Second Amendment dated July 22, 2024 [2024-0511], and the Third Amendment dated September 25, 2025 [2025-0747] (collectively referred to as the “Interlocal Agreement”), which provided funds necessary for the design of certain shared use path/trail improvements referred to locally as Phase 2 of the Alamo Alto section of the Paso del Norte Trail, within Tornillo, Texas (the “Project”); and

WHEREAS, the design plans are complete, the CRRMA has selected a construction contractor, and the Parties now desire to advance the Project to the construction phase and therefore, the Parties desire to further amend the Interlocal Agreement in order to increase the funding available to allow for the commencement of construction activities.

NOW, THEREFORE, in consideration of the mutual covenants and agreements herein contained, the undersigned Parties agree as follows:

1. Replacement of EXHIBIT C-3. The parties hereby agree to delete **EXHIBIT C-3** from the Interlocal Agreement in its entirety and replace it with **EXHIBIT C-4**, which is attached hereto and incorporated herein for all purposes.

2. Ratification. Except as expressly amended by this Amendment, the Interlocal Agreement and its exhibits shall remain in full force and effect.

3. Execution in Counterparts. This Amendment may be simultaneously executed in several counterparts, each of which shall be an original and all of which shall be considered fully executed as of the date first written above, when both Parties have executed an identical counterpart, notwithstanding that all signatures may not appear on the same counterpart.
