CAMINO REAL REGIONAL MOBILITY AUTHORITY INVITATION TO BID

Sealed bids will be received before the bid due date shown below for the **El Paso County Passenger Shelters & Sidewalks Program**.

PROJECT DESCRIPTION: This project consists of the construction of four (4) proposed bus passenger shelters with associated reinforced concrete foundations, concrete sidewalks, bus stop signage, bike racks, trash receptacles, benches, advertising display cases, and solar powered lighting. These passenger shelter activities will be located at Homestead Meadows, Horizon City, Tornillo, and Westway in El Paso County.

This project also includes ADA compliant sidewalk/ramp improvements, crosswalk markings, and signage along La Union Avenue and Central Avenue from Doniphan Drive to 5th Street in Canutillo, Texas. Such sidewalk activities include the demolition of existing concrete sidewalks, construction of new passenger bus shelter pads, reconstruction of concrete sidewalks, and new concrete sidewalks. The project also includes but is not limited to demolition and reconstruction of existing driveways, demolition and reconstruction of existing concrete sidewalks, grading, demolition and reconstruction of concrete curb ramps, restriping of crosswalks, demolition and reconstruction of concrete curb and gutter, and asphalt patchwork.

Various bid items and their associated quantities have been provided in this bid proposal in order to establish unit bid prices for the proposed work. The bid items and quantities are based on historical data and are not guaranteed. Actual quantities of work to be performed and paid will be determined in the field by the Project Engineer and will be paid utilizing these unit bid prices with no further compensation made regardless of the final quantities.

Plan sheets are provided as part of this bid proposal for the construction activities noted above. However, upon the availability of funds, additional similar construction activities (bus passenger shelter and sidewalk work similar in nature to those activities noted above) are anticipated to be awarded through this Contract via change order, pursuant to and in accordance with Texas Local Government Code Section 271.060.

The Contract will be in effect until the work on the last callout is completed and all project documentation provided.
